2. Definitions and Explanations

- One company has the right to exercise a dominant influence over another company pursuant to a contract or a provision in the articles of association,
- One company, which is a shareholder or partner in another company, controls alone, by virtue of an agreement with other shareholders or partners of that company, a majority of the shareholders' or partners' vot-

Companies that are in any of the above relationships with one or more other companies shall also be considered as a single undertaking.

In the event of mergers or acquisitions, all de minimis aid granted to the participating companies during the previous three-year period must be taken into account. In the context of company spin-offs, the de minimis aid is to be attributed to the company retaining the business activity, for which the aid was granted. If this is not possible, the allocation shall be made on the basis of the book value of the equity at the time of the actual spin-off.
